Instructions for Uttarakhand State NEET PG MDS 2024 Round-III Online Centralised Counselling

- 1. The following category of candidates are eligible for UttarakhandState NEET PG MDS 2024 Online Centralized Round-III of Counselling after fresh registration-
 - * The interested and eligible candidates who are already registered for round-I & II but not allotted any seat.
 - * All Candidates who have taken admission against seat allotted in round-I & II are eligible for seat/college/quota up-gradation in round-III of counselling.
 - * Candidates who have not taken admission against the round I &II of allotment or have withdrawn after taking admission are also eligible to appear in round-III of counselling.
 - * New eligible candidates who wish to participate in round III counselling.
- 2. If the candidates registered in round-I & II is not interested to participate in round-III of counselling or is satisfied with the allotted seat he/she is advised not to register/fill choice in round-III of counselling. So that the seats can be allotted to the eligible registered candidate in order of merit & to curb the malpractice of seat blocking.
- 3. The applicants are required to fill the online application form to register and pay the required registration & security fee only by ONLINE mode (by NET Banking/Debit/credit card only). The counselling registration fee shall not be refunded in any circumstances. Please refer to the Counselling Schedule and Instructions for details
- 4. The detailed information regarding security fee to be deposited is available on university website www.hnbumu.ac.in as a separate link.
- 5. The candidate who has already deposited registration fee & security deposit but not completed the online application form further in round-I and wish to participate in round-III of counselling have to re-register themselves in the NEET PG MDS counselling link on university website www.hnbumu.ac.in & fill all necessary required information again, failing which they will not be considered for round-II of counselling. The candidate has to fill fresh choice for round-II but they are not required to pay registration fee & security fee deposit again
- 6. The candidate who has already deposited Rs. 6500/- as registration fee but not deposited the security fee can participate in the round-III counselling, by depositing security fee only after re-registration. Such candidates are also required to fill all essential information as required for counseling &to fill new choices to remain eligible for round-III of seat allotment.
- 7. The candidates who have neither deposited the registration fee nor the security fee have to follow the instruction given in point no-3 and complete all the formalities of registration fee, filling the required information, security fee & choice filling as per rules.

- 8. The candidates who fail to complete the formalities of round-III of counselling like reregistration, registration fee deposit, security fee deposit (if applicable) and fresh choice filling within stipulated time will not be considered eligible for round-III of seat allotment. Hence candidates are advised to read the counselling schedule and complete the formalities on the prescribed time line.
- **9.** The candidates have to complete the online application form in all respect and also to upload his/her photograph & signature (as submitted in NEET PG MDS- 2024) and all other relevant entries in the appropriate box. The candidates are further advised to re-check the entries/information given byhim/her before submitting the same. After submitting the form, the candidates are required to take the print of the submitted form (hard copy). The candidatesare advised to retain the copy of the form submitted their best Interest for further reference and Queries.
- 10.After final submission if a candidate wishes to edit any information within time schedule of registration, the candidate has to payan additional fee of Rs.500/- only each session for editing (only by online mode). For this candidate has to click "PAY CORRECTION FEE" link after Login. Under any circumstance NO time extension will be permitted for editing the information. After editing the previous entries & Hard copy of print out will be treated Null & Void.
- 11.Allotment on available State Quota seats and All India Quota seats for NEET PG MDS 2024 Uttarakhand State Round-III of Online Centralized Counselling will be held purely on the basis of NEET PG MDS -2024 merit-cum-preferences of the interested eligible candidates.
- 12. The seats remaining vacant in vertical and horizontal category due to non availability of eligible interested registered candidates will be converted to other categories as per rules in the third round of counselling.
- **13.** In Round III the clause/Condition of Security fee Forfeiture will apply, the Candidates are advised to select the choices for round-III very carefully. If candidates are not interested in any specific subject/ specialization/college/ quota, it is advised not to select that specific subject/ specialization/college/ quota in choice filling process.
- 14. If the candidate gets the allotment against the new choice, the seat allotted in the first and second round will be automatically cancelled and will be allotted to next eligible registered candidate. The Counselling board/University will not be responsible for any mistake committed on the part of the candidates during choice filling.
- 15. If the candidate do not get the allotment against the new choice, the seat allotted in the first and second round will be retained by the candidate. But in this condition the candidates will not be permitted to vacate/surrender the admitted seat of round-I and round-II as per specific time given by counselling board.
- 16. Candidates must keep a printout of choice filled for future reference.
- 17.All the interested eligible candidates are advised to select as many choices as per their preference(s) irrespective of seat status shown in seat matrix.
- 18. These choices will be valid only for III round of counselling.
- 19. The allotment letter will be available to the candidate along with necessary instructions

through the University website. The printout of this allotment letter will have to be produced by the candidate at the time of admission to the collegeallotted to him/her. No extension will be permitted for last date of admission.

- 20.Candidates who have been allotted the seat have to report to the concerned college in person along with all required original documents for verification as well as the balance required fee (other than advance tuition fee) for confirmation of admission.
- 21. The candidates who have taken admission against the seat allotment of Uttarakhand State NEET PG MDS 2024 round-I& II counselling have a last opportunity to vacate the allotted seat with forfeiting security deposit. The last date to vacate the seat will be by 23-08-2024, 05:00 PM through online mode only. After 23-08-2024, 05:00 PM candidate will not be permitted to vacate the seat under any circumstance.
- 22. If a candidate fails to secure the admission in the seat allotted of round-III of counselling the security fee deposited by the candidates stands forfeited. However, such candidate can not participate in next round (If any) counselling.
- 23. The candidates who secure a PG seat in round-III of seat allotment will not be permitted to vacate/surrender the seat. The counselling board will not be responsible for any negligence in the part of the candidate.
- 24. The detailed procedure and information regarding admission procedure will be uploading separately after the declaration of the round-III result.
- 25.Round-III of counselling will be held subject to the availability of vacant seats only and detail guidelines will be intimated separately.
- 26. Please refer to Information Bulletin- NEET PG MDS 2024 for further information.

27. Any or all the above-mentioned rules and regulations may change as per the directions of the Hon'ble Court(s)/ regulatory bodies/State Government.

- 28. The candidates already under bond for compulsory service in Uttarakhand have to fulfil the conditions mentioned in the bond or as specified by State government, DGH&FW, Uttarakhand and Hon'ble High Court from time to time. The Counselling board/University will not be responsible for any legal issues arising out of matter related with such bond or service conditions.
- 29.In-service candidates of State of Uttarakhand/other states/central Government/PSU, etc will also have to fulfil the conditions mentioned in their service rules.
- 30. The security fee will not be adjusted against the Tuition or any other Fee. The security fee (if not forfeited)/excess deposit (if any) will be refunded separately only after one month of completion of Round-III of counselling.
- 31.If a candidate freshly registers in round III and is not allotted any seat, he/she is eligible to participate in further rounds.
- 32. The latest information and procedure of counselling will be uploaded on university website on the basis of directions/advisories received from Govt. of India, Medical counselling Committee, NMC, Govt of Uttarakhand from time to time. The latest directions uploaded on the website by UK NEET MDS–PG counselling board will only be applicable and will replace any such condition/term/rules mentioned in the

information bulletin. The decision taken by UK NEET MDS–PG counselling board related to procedure of counselling will be applicable at all time. Hence candidates are advised to visit the university website regularly for any update. No separate information will be sent to the candidate.
