## PROCEDURE FOR SEEKING ADMISSION TO MBBS COURSES UNDER FOREIGN INDIAN STUDENTS (NRI) QUOTA PRIVATE UNIVERSITIES of UTTARAKHAND (INDIA) SESSION - 2024-25

As per Uttarakhand Government notification No247890/XXVIII(5)/2024-(E-78579) dated 18/10/2024. 15% seats in Shri Guru Ram Rai Medical Institute of Medical Sciences, Dehradun shall be earmarked for the Non Resident Indian. (Details enclosed as Annexure-I)

All admissions of NRI Quota shall be based on the merit of National Eligibility-cum - Entrance Test (NEET-2024)

For ascertaining the eligibility relevant documents including Foreign Country Passport or Green Card or Permanent Resident Card or Proof of Residency of Foreign Country issued by competent authority or OCI/PIO Card issued by the Government of India Shall be taken into consideration (Detailed Sample Format is attached Annexure-II)

The priority of Allotment Under NRI Quota will be as per conditions mentioned in the Uttarakhand Government notification No-247890/XXVIII(5)/2024-(E-78579) dated 18/10/2024 All the relevant documents in support of eligibility and NRI category will be verified by allotted College at the time of admission

माध्यम से श्री गुरु राम राय इन्स्टीट्यूट ऑफ मेडिकल एण्ड हैल्थ साइंसेज, पटेल नगर,  
देहरादून में एन०आर०आई० कोटे के अन्तर्गत 15% सीटें प्रदान किये जाने का अनुरोध  
किया गया है।

2- उक्त के संबंध में शासन स्तर पर सम्यक निर्णयोपरान्त मुझे यह कहने का  
निदेश हुआ है कि श्री गुरु राम राय इन्स्टीट्यूट ऑफ मेडिकल एण्ड हैल्थ साइंसेज, पटेल  
नगर, देहरादून को अखिल भारतीय कोटे की सीटों में से 15% सीटों पर एन०आर०आई०  
श्रेणी में प्रवेश NEET 2024 की मेरिट के अनुसार दिये जाने की स्वीकृति निम्नलिखित  
उपबन्धों के अधीन प्रदान की जाती है :-

- (1) एन०आर०आई० कोटे के अन्तर्गत केवल NEET 2024-25 प्रवेश परीक्षा उत्तीर्ण  
उम्मीदवार ही पात्र होंगे। एन०आर०आई० कोटे की सीटों के अन्तर्गत सभी प्रवेश  
NEET की मेरिट के अनुसार होंगे।
- (2) पी०आई०ओ०/ओ०सी० और विदेशी नागरिक जो नीट योग्य हैं, वे भी  
एन०आर०आई० श्रेणी के तहत आवेदन कर सकते हैं। एन०आर०आई० कोटे के लिए  
वरीयता निम्नानुसार निर्धारित की जायेगी :-
  - (i) वास्तविक एन०आर०आई० उम्मीदवार जो मूल रूप से उत्तराखण्ड राज्य से  
संबंधित हों।
  - (ii) एन०आर०आई० के बच्चे जो मूल रूप से उत्तराखण्ड राज्य के हों।
  - (iii) वास्तविक एन०आर०आई०, जो मूल रूप से उत्तराखण्ड के अलावा किसी अन्य  
भारतीय राज्य और केन्द्र शासित प्रदेश के निवासी हों।
  - (iv) एन०आर०आई० के बच्चे जो मूल रूप से उत्तराखण्ड के अलावा किसी अन्य  
भारतीय राज्य और केन्द्र शासित प्रदेश के निवासी हों।
  - (v) अभ्यर्थी के सगे भाई और बहन हो।
  - (vi) यदि छात्र का प्रथम श्रेणी संबंधी एन०आर०आई० हो और विदेश में रहता हो

तथा अभ्यर्थी निम्नलिखित शर्तें पूरी करता हो :-

(क) वह निकटतम रिश्तेदार होना चाहिए।

(ख) निकटतम रिश्तेदार की परिभाषा में, उम्मीदवार का निम्नलिखित रक्त संबंध होना चाहिए :-

(i) पिता के सगे भाई और बहन अर्थात् सगे चाचा और बुआ।

(ii) मों के सगे भाई और बहन अर्थात् सगे मामा और मौसी।

(iii) पिता के पिता और माता अर्थात् दादा और दादी।

(iv) माता के पिता और माता अर्थात् नाना और नानी।

(v) प्रथम डिग्री-पैतृक और मातृ चचेरे भाई।

(ग) ऐसा व्यक्ति एन0आर0आई0 होना चाहिए।

(घ) ऐसे व्यक्ति सामान्यतः विदेश में निवास करते हों

(ङ) ऐसे व्यक्ति को छात्र के अभिभावक के रूप में छात्र की देखभाल करनी चाहिए तथा इस आशय का साक्ष्य ऐसे व्यक्ति द्वारा प्रस्तुत किया जाना चाहिए।

(vii) एन0आर0आई0/पी0आई0ओ0/ओ0सी0आई0 की सूची समाप्त होने के बाद विदेशी नागरिकों को एन0आर0आई0 कोटे के तहत प्रवेश के लिए विचार किया जाएगा।

(viii) यदि उपरोक्त उप प्रस्तर-(vii) में अंकित कोटे में भी सीट रिक्त रहती है तो इस दशा में उक्त सीट को अखिल भारतीय कोटे से भरा जाएगा।

(ix) प्रवेश पाने वाले अभ्यर्थियों को उत्तराखण्ड के दुर्गम/पहाड़ी क्षेत्रों में 03 वर्षों की सेवा दिए जाने हेतु अनिवार्य सेवा बॉन्ड किया जाना आवश्यक होगा।

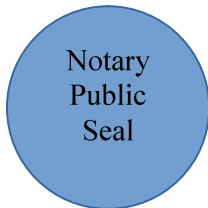
