

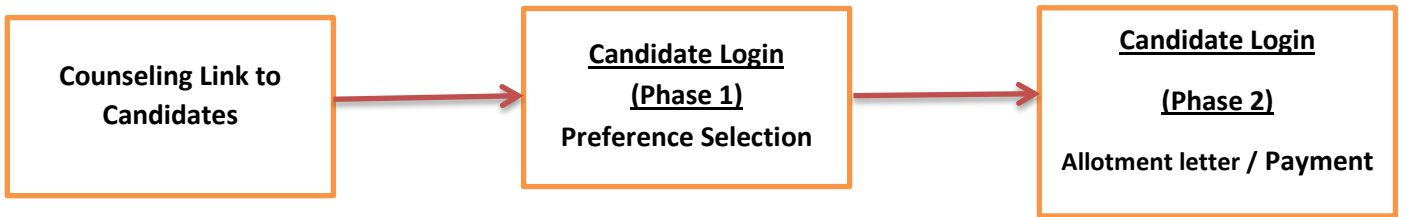

### ➤ Counseling Flow




## ➤ Counseling Link

- 1) Once the document verification is completed, the link for online counseling will be sent to the shortlisted candidates through E-Mail / SMS and the link will be published in TNDALU website.
- 2) Only the shortlisted candidates will be able to login and participate for the counseling.

## ➤ Candidate Login (Phase-1)

- 1) Login: The candidates should login using their Application Number and DOB(DD/MM/YYYY)
- 2) The application number will be mentioned on the application form starting with ALC for affiliated law colleges.

**Preferences Selection:**

- The candidate needs to select a minimum of 14 preferences. If the candidate selects less than 14 preferences he/she will be not able to submit the preference.
- By following the steps below the college preference should be selected Depending upon the application,

Step 1: By default the Course will be selected.

Step 2: Candidate should select the College from the drop down.

Step 3: Candidate should enter the preference order in numeric, and the seat allocation will be done as per the preference order entered by the candidate and the seats available.

Step 4: Once the above steps are completed the candidate should click on submit to save the preferences.

Example: 1) Preference 1: Dr. Ambedkar Govt. Law College, Pudhupakkam

2) Preference 2: Govt. Law College, Madurai

3) Preference 3: Govt. Law College, Trichy

If the seat is not available in Dr. Ambedkar Govt. Law College, Pudhupakkam entered as Preference order 1 the seat will be allotted in Govt. Law College, Madurai entered as preference order 2 if the seat is not available in preference order 2 also the seat will be allotted in Govt. Law College, Trichy entered as preference order 3 and goes on.

- Once the candidate click on the submit button it will be final and there after the candidate will be not able to change their preference. If the candidate does not click on submit button the preference shall not be submitted.
- Once the candidate submits their preference the print option will be enabled and the candidate can take the printout of their preference submitted.

- If the candidate fails to select any of the preference with in the given date and time, the same shall be considered as **absent for the Counseling Process**.
- Once the preference is submitted it will take around 24 to 72 hrs for allotting the seats candidate has to wait till further intimation.

2) The Candidate can take the print out of the admission letter and join the college as per the instructions given on the admission letter.



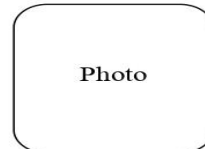

On Admission, the Candidate is required to pay a sum of **Rs.1,620/- (Rupees One Thousand Six Hundred and Twenty Only)** towards the University Fee either through **Bank Challan (Canara Bank) or Online Payment Gateway** available in the University Website ([www.tndalu.ac.in](http://www.tndalu.ac.in)). The Differently Aabled Candidates are fully exempted from payment of University Fee. However, they have to pay Rs.10/- only (Rupees Ten Only) towards Admission Fee.

The counterfoils of the Payment Challan or the Receipt of the Online Payment of University Fee must be submitted with the Office of the Principal of the Allotted Law College during Admission.

The Candidate has to submit the following Original Documents at the time of Admission and surrender them to the Principal of the Allotted Law College **on or before 13.11.2020.**

1. Mark Statement of the SSLC (10<sup>th</sup> Std.).
2. Mark Statement of the HSC (12<sup>th</sup> Std.).
3. Transfer Certificate (TC) and Conduct Certificate.
4. Passport size Photographs (3 copies) recently taken.
5. Community Certificate in specified format (If applicable).
6. Special Category Certificate obtained from the Appropriate Authority (If applicable).
7. Eligibility Certificate (Applicable to candidates other than those qualified under State Board of Tamil Nadu).
8. First Graduation Certificate (If applicable).
9. Sworn Affidavits for non- involvement in Ragging are to be submitted by the Students and their Parents / Guardians in the format of Annexures X, XI & XII in accordance with the UGC Regulations, 2009.
10. Eligibility Certificate can be obtained from the Office of the Registrar, The Tamil Nadu Dr.Ambedkar Law University by submitting an Application in the prescribed form with a Bank Challan/Demand Draft for a sum of Rs.1000/- (Rupees One Thousand Only). Candidates from other State need to pay a sum of Rs.2000/-.

NOTE: 1. The Provisional Allotment subject to the University Regulations and the Rules prescribed by the Government of Tamil Nadu. The Government and the University Reserve the Rights to Cancel the Admission at any time for valid Reason.  
2. Fees once paid shall not be refunded.
